- Hunters must confirm their Eligibility to Hunt in sections D-1 and D-2 before they are permitted to purchase recreational hunting licenses.

D-1 Eligibility to Hunt Requirements

I am not currently under a licence suspension in Alberta that prohibits me from obtaining or holding a recreational hunting licence;
